A RESOLUTION AUTHORIZING THE PARISH PRESIDENT TO EXECUTE AN AGREEMENT WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION (LADOTD) FOR IMPROVEMENTS AT ST TAMMANY REGIONAL AIRPORT.

WHEREAS, Act 451 of the 1989 Regular Session of Louisiana Legislature Authorized the financing of certain airport improvements from funds appropriated from the Transportation Trust Fund; and

WHEREAS, the St. Tammany Parish Government has requested funding assistance from LADOTD to/for Obstruction Mitigation-Phase I (Design); and

WHEREAS, the stated project has been approved by the Louisiana Legislature and the LADOTD is agreeable to the implementation of this project and desires to cooperate with the St. Tammany Parish Government according to the terms and conditions identified in the attached Agreement;

WHEREAS, the LADOTD will provide the necessary funding for the Runway Rehabilitation -Phase II (Construction) and reimburse the sponsor up to \$128,015.00 of the project cost.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that it does hereby authorize the Parish President to execute an Agreement for the project identified as AIP No. 3-22-0012-014-2022 and SPN H.015182, more fully identified in the Agreement attached hereto; and to execute any subsequent related documents, including, but not limited to, amendments to said agreement. This resolution shall be in full force and effect from and after its adoption.

ADMINISTRATIVE COMMENT

Resolution authorizing the Parish President to execute a grant agreement with LADOTD for an amount of \$128,015. The grant will provide a portion of the funding for mill and overlay of the runway at St. Tammany Regional Airport. The total project cost is \$1,362,316.60. Funding breakdown as follows: FAA (90%) \$1,152,134; LADOTD (10%) \$128,015; and local funds \$82,168.60. The local funds will be reimbursed by FAA and LADOTD in the FY'23.
