RESOLUTION TO VACATE, IN PART, THE SIX (6) MONTH MORATORIUM ESTABLISHED BY ORDINANCE C.S. NO. 16-3459, AND ANY SUBSEQUENT EXTENSION THEREOF, ON THE ISSUANCE OF PERMITS FOR CONSTRUCTION OR PLACEMENT OF BUILDING STRUCTURES ON PROPERTY WITHIN A DEFINED AREA NORTH OF NORTH STREET, SOUTH OF HARRISON AVENUE, WEST OF RAVINE STREET, AND EAST OF EIKE STREET AND FUSCHIA STREET WITHIN UNINCORPORATED BOUNDARIES OF WARD 3, DISTRICT 5.

WHEREAS, pursuant to Ordinance C.S. No. 16-3459, in order to protect and preserve the health, safety and property interests of residents from the adverse effects of flooding hazards resulting from severe drainage problems and flooding within a certain portion of unincorporated Ward 3, District 5 of St. Tammany Parish, it was necessary to impose a temporary moratorium on the issuance of permits for construction or placement of any building structures within said area in order to allow sufficient time for completion of a funded drainage study and completion of drainage improvements;

WHEREAS, it has been determined that the properties identified herein below as A and B are not contributing to the flooding hazard within the defined area and are therefore to be released from the moratorium.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish Council vacates, in part, the moratorium established by Ordinance C.S. No. 16-3459, and any subsequent extension thereof, on the issuance of permits for the construction or placement of building structures within the designated area of unincorporated St. Tammany Parish, Ward 3, District 5, to remove therefrom the restrictions established by the moratorium on the following two (2) described properties, to-wit:

A. A CERTAIN PORTION OF GROUND, together with all the buildings and improvements thereon, and all rights, ways, means, privileges, servitudes, prescriptions, advantages and appurtenances thereunto belonging or anywise appertaining, situated in the Parish of St. Tammany, State of Louisiana being a portion of Section 12, Township 7 South, Range 11 East, and more particularly described as follows:
