DISCUSSIONS AND OTHER MATTERS

Lorino -1. Motion to refer to the Zoning Commission for recommendation the rezoning of Lee Road School located at 79131 Highway 40, Covington from its current zoning of A-1A (Residential District) to ED-1 (Primary Education District). (Fitzgerald)

Fitzgerald - this request is to correct improper zoning at Lee Road School.

Carlo Hernandez – this is one of 55 schools under the million doller school board budget. The A-1-A zoning was given during comprehensive rezoning 10 years ago. The Council is waiving \$2,425 in fees. He wants to volunteer to review the other 54 schools for proper zoning, if, the school board pays the necessary fees to correct the problems.

Cazaubon – this school is surrounded by residential zoning and was missed in comprehensive rezoning, but many properties have been rezoned without fees trying to correct the issues.

Jeff Schoen – the school board is contemplating the expansion of the school, and they can use the waived fees directly on education. It is the best use of their budget.

Canulette – the school board has been nothing but a wonderful neighbor and the money can better be spent on educating our children.

Fitzgerald - move to refer for recommendation, second by Canulette. Unanimous with no one absent.
