PUBLIC HEARING – BOARD OF REVIEW

In accordance with the provisions of LA. R.S. 47:1992, the St. Tammany Parish Council hereby convenes in public session as a Board of Review to entertain complaints and/or appeals from any taxpayer(s) aggrieved by ad valorem assessments levied against his/her/their property.

The Assessor of St. Tammany Parish has duly advertised notice of this public hearing in accordance with law. The deadline for receipt of appeals by taxpayers to the Board of Review will be 4:30 p.m. September 11, 2023. If no appeals are lodged by this date, or if appeals are lodged but resolved through the Parish Assessor's Office, the time will automatically expire and terminate without the need for the Parish Council to reconvene to so declare.

- Canulette – moved to adopt the Consent Calendar, less items pulled, seconded by O'Brien. Unanimous with one (1) absent (Toledano).
- Airey - 16. **Ordinance Calendar No. 7373** - Ordinance to amend the 2023 Capital Improvement Budget and Capital Assets – Amendment No. 46 – Parishwide Roads & Drainage Capital Projects (Dean/Fitzgerald)
- Terri Lewis Stevens – Congratulated new Planning and Zoning members. Asked about the contract since the original contractor went bankrupt and now it is significantly higher. Said she would like to see a copy of the contract to see the changes. Asked if there is a completion date and about the liquidated damages if they go over the date. She also asked if they had liability insurance.
- Airey – said this is probably in litigation because of the original contractor.
- Stevens – said that is what the comment said, but she wants to be sure of it and the other things she stated.
- Canulette – asked about the contractor and if they are on the bad contractor list.
- President Cooper – said they have no other contracts in the Parish.
- Tanner – asked again if they will go on the list.
- President Cooper – said they will not be selected for any other jobs.
- Canulette – moved to introduce, seconded by Lorino.
- Airey - 20. **Ordinance Calendar No. 7377** – An ordinance to impose a six (6) month moratorium on receipt of submissions by the Parish Planning and Zoning Commission for the placement of mobile home overlay or re-subdivision or re-zoning of property and/or on the issuance of permits by the Parish Department of Planning and Development/Permits for the construction or placement of any mobile home in the Howard O'Berry Road area in District 6, all as more particularly described herein and on the attached map. (Ward 4, District 6) (Tanner)
- Tanner – said she wants to amend this ordinance to broaden the area because there is a large piece of property that is A-4 and they want it A-2.
- Liner – explained further.
- Tanner – asked Smith if he had any questions because this will be in his area.
- Smith – asked for further clarification.
- Liner – explained that this hasn't been looked at for many years.
- Smith – asked if something sparked this.
- Tanner – explained why this came up which was because Development wasn't sure which ones were permitted.
- Campo – said if she amended it, it would have to go up on the website again for 30 days.
- Janice O'Berry – said the road is named after her grandfather. Said she hasn't seen anyone come from the Southshore and drop off trailers. She said she agrees that this needs to be rezoned, but she doesn't agree with the wording because people can't subdivide. She asked if it goes from A-4 to A-2 does it have to go through a study?
- Liner – said the Councilperson has the right to remove a property from a moratorium by resolution. He said they can't just change the zoning; a study needs to be done.
- Glen Payne – said he lives on the road. He is for it being changed from A-4 to A-2. He said it needs to be A-2. He is asking them to take the time to do it right.
- Cazaubon – said they should just do the Mobile Home Overlay now because of advertisement. She also spoke about replacing a mobile home to answer Tanner's question.

- Liner – explained that the property already has a Mobile Home Overlay, but they are trying to limit the number.
- Canulette – said this can be a real issue. He asked if there is any way to stop taking receipts.
- Tanner – said there are two acres where they want to put a new trailer and one to replace.
- O'Berry – asked about if someone came within the next 30 days what would happen?
- Davis – asked about the area and the underlying zoning and what the mission is. He said wouldn't this be the same as spot zoning, but in reverse.
- Liner – said no, that this is the same thing they did on Lake View Dr. and it had a great outcome. He also reminded them that you have to get permits to bring in structures.
- Tanner – moved to introduce, seconded by Canulette.
- Airey - 23. **Ordinance Calendar No. 7380** - Ordinance to amend St. Tammany Parish Code of Ordinances, Article VI, Division 1, pertaining to parish buildings, to add Section 2-216 prohibiting animals on election day in parish buildings being utilized as polling locations. (Airey/Cooper)
- Smith – made comments about this ordinance and what he has been trying to get done with this.
- Smith – moved to introduce and refer to the Planning Commission, seconded by Laughlin. Unanimous with no one absent.

APPEALS

Each side is allowed ten (10) minutes to present their case and three (3) minutes for rebuttal, a two (2) minute conclusion per side may be allowed if questions are asked by the Council.

- Airey - 1. Gerard Collins, Jerry Swenson, Peter Hebert, et. al. (43 total) appealing the Planning Commission APPROVAL WITH WAIVERS at the June 13, 2023 meeting for Minor Subdivision of Parcel 3 into Parcels 3-A, 3-B, 3-C, 3-D, and 3-E on property located on the south side of Stein Road, west of Clarence Road, Sun, Louisiana. (Ward 5, District 6) (2023-3357-MSP) Owner & Representative: Kain Brake, LLC – William Magee; Surveyor: John G. Cummings & Associates (Postponed 08/03/2023)

NOTE: To concur with Planning APPROVAL, a majority vote of the Council is required and adoption of a resolution.

NOTE: To override Planning APPROVAL, a 2/3 majority vote of the Council is required and adoption of a resolution.

APPELLANTS

- Jerry Swenson – in favor of the appeal.
- Brian Blackwell – resident of the Village of Sun. Said 3 bus drivers live on the road. Spoke about drainage problems. Said 2 bus drivers can't pass on the road. Cleared up misinformation given at the zoning meeting. He said Bill Magee has 59 acres in the Village of Sun. He is asking that they consider the right information even if they have to table this appeal. He asked the Council to expand the moratorium to contiguous areas.

****There was one other speaker who did not want to speak.**

OWNER

- Bill Magee – explained that he wanted to do a minor subdivision on 16 acre tract of land to build some houses. He said the road is a public paved road. He said he followed rules of the Parish to the T. Only 1 lot fronts Stein Rd because he is doing a private road. He said that Zoning overwhelmingly approved this. He was never told that he needed a drainage study. He said the flooding was in the Village of Sun. He thinks the roadway is adequate. He said none of

the objections have anything to do with a minor subdivision. He said it is an improvement to the density and there is no reason to overturn the decision.

REBUTTAL

-Blackwell – said there is supposed to be 3 families spread over 125 acres. He said he was asking for the moratorium to be expanded over the 59 acres that are not in the Village of Sun.

-Swenson- asked a question about drainage.

-Tate Callo – said he owns property around the subdivision. He spoke about flooding and the owner not asking him to put a drainage line through his property.

REBUTTAL

-Magee – said he doesn't know the last gentleman because he owns some of the surrounding property and knows the other owner, but the bottom line is this is St. Tammany Parish. He said the concerns are not applicable to the minor subdivision. He said there is no grounds for granting the appeal.

COUNCIL DISCUSSION

-Tanner – called up Vincent Wynn, counsel for the Village of Sun, and asked him to explain the moratorium and the area. Said there are no land use ordinances. There are only 68 ordinances in the Village of Sun. They recently passed an ordinance for 1 house per 5 acres. He said they have the moratorium because there is a lot of things that are coming to the Village of Sun. He said there was a request to annex, but the Council was concerned because there are no rules in Sun.

-Tanner – asked Daniel Hill about a drainage study.

-Hill – answered that there is no drainage study required for a minor subdivision.

-Cazaubon – said that the same thing is happening in her area and in Tangipahoa Parish. She said she knows this area well and is concerned. She said they need to look at how the area is developed. She said she would like to table this until a study could be done. She wants to know how many acres are attached to this in the Village of Sun.

-Davis – asked if this was in a critical drainage area and is there no concern for flooding.

-Hill – explained that they are concerned, but critical drainage areas are not covered in minor subdivisions.

-Canulette – spoke about Sun being a gem and it deserves to keep its integrity. He said they should be working with the Village of Sun to protect it. He said Sun needs to stay Sun and they need to help them succeed.

-Tanner – said she has always said that zoning is the hardest thing she has had to do. She said she was born and raised in Sun and has acreage. She said her concern is what is the plan for developing the rest of the property? She said she likes 5 acre lots. She said she has been on this road numerous times and it is not the ideal road. She said buses have to pull over. She is concerned about density and safety of people on the road.

-Tanner – moved to override the Planning Commission approval with waivers, seconded by Davis. Unanimous with no one absent.

-Tanner – moved to adopt a resolution, seconded by Canulette. Unanimous with no one absent; becomes Resolution Council Series No. C-6827.

-Airey - 2. Loyann Jenkins appealing the Zoning Commission DENIAL on August 01, 2023 to rezone 1.29 acres located on the west side of LA Highway 437, east of Hulin Road, Covington from A-1 (Suburban District) to A-1 (Suburban District) and MHO (Manufactured Housing Overlay). (Ward 3, District 2) (2023-3429-ZC) Petitioner: Loyann Jenkins; Owner: Loyann Jenkins

NOTE: To concur with Zoning DENIAL, a simple majority vote is required and adoption of a resolution.

NOTE: To override Zoning DENIAL, a majority vote of the entire Council is required and introduction of an ordinance.

APPELLANT

- Loyann Jenkins – said she wants to put a mobile home on the property for her elderly aunt. She said Zoning said no mobile homes are in the area, but that is not accurate. She said there are multiple mobile homes in the area.

COUNCIL DISCUSSION

- Fitzgerald – said Ms. Jenkins is trying to do something genuine for her aunt. He said she is placing a new mobile home, and it will be in a heavily wooded area with a large buffer.
- Cazaubon – said she is familiar with the area and agrees with this.
