# Administrative Comment Amendment No. 12 - 2021 Operating Budget - October 2021 OFF-THE-FLOOR

This budget amendment is to:

## a. 502 - UTILITY OPERATIONS FUND

To amend the budget to increase expenditures for the construction of a new 0.75 million gallon per day wastewater treatment plant (WWTP) and a 400,000 gallon equalization basin on the current WWTP site.

This Ordinance is presented off-the-floor to secure funding and continue project progression.
