CDBG Substantial Amendment to the 2019 Annual Action Plan

Add the CARES Act Funding

Summary:

According to St. Tammany Parish's Citizen Participation Plan and Federal Regulations, changes made in allocating St. Tammany Parish's Community Development Block Grant (CDBG) program funds constitute a substantial amendment to the Annual Action Plan. The proposed changes include allocation of \$703,190 and in the addition of the 2nd allocation of \$927,463 for CARES Act funding.

Fiscal Impact:

There is no fiscal impact. The U.S. Department of Housing and Urban Development determines the Community Development Block Grant Amount that the Parish receives. The proposed changes to the program will not affect the total amount of funding and will involve only the re-allocation of resources due to the pandemic when preparing, preventing, or responding to COVID-19.

Background:

St. Tammany Parish's Citizen Participation Plan requires a substantial amendment when funds are moved between eligible projects. However, The U.S. Department of Housing and Urban Development, issued a waiver to amend our current action plan to add the allocation of CARES Act funding, which at the time we decided to amend our 2019 Annual Action Plan. These changes therefore required the modification of St. Tammany Parish's 2019 Annual Action Plan.

The proposed CDBG program changes include:

- The addition of \$703,190 CARES Act Funding
 - o \$100,000 Habitat for Humanity
 - o \$100,000 Food Bank
 - o \$30,000 Family Program
 - o \$140,638 Program Admin (20% Cap)
 - o \$332,552.00 Unobligated
 - We plan to request for additional proposals to assist more non-profits when responding, preparing, and prevent COVID-19.
- The addition of \$927,463 CARES Act Funding

o All in unobligated, but we plan to request for proposals to assist non-profits due to the pandemic when responding, preparing, and preventing COVID-19.

Citizen Participation:

As outlined in St. Tammany Parish's Citizen Participation Plan, substantial amendments to the Consolidated Plan will be required when changes in the use of CDBG funds are proposed from one eligible activity to another or when projects are added or deleted from the plan. When a substantial amendment is proposed, the Parish will provide citizens with at least 5* days notice prior to implementation of the amendment. *Due to COVID-19, we have been issued a waiver to give citizens a 5-day notice instead of 30 days,

Notice of the proposed amendment was published in at least one newspaper (Farmer) of general circulation. The Parish will consider any comments or views of citizens received in writing, or orally at public hearings. A summary of these comments and views will be attached to the substantial amendment.
